## About XFT Task Manager

#### Flexible Electronic Files with Process Management

In practically every business process, you use documents and SAP objects – from creating a contract, to hiring a new employee, and editing a quote. The more complex the process, the more difficult it is to maintain an overview. Which tasks still need to be completed? Will the deadlines be met? Have you got all necessary approvals? What have your employees already discussed with the customer?

XFT Task Manager enables you to map your business processes in process files or gather information about your business partners, products, and other objects – all in a single system. The software combines electronic file management with functions for structured task management – integrated directly into your SAP system. In this way, you always have the information you need at a glance.

## Overview of Features

#### File Functions

- File structure, views, and functions can be defined in the file template
- Flexibly definable header data area with an overview of the most important file and process attributes as well as relevant SAP master data and context data
- Flexibly definable column configuration (approx. 40 standard columns plus 10 free columns)
- Ad-hoc enhancement by the user can be permitted
- Authorization-based control of visibility and functions
  - o Integrated use of the SAP user role and authorization system
  - Enhanced authorization concept for mapping complex authorizations
- Clear logging
- Classification of tasks and objects
- Note function for creating ongoing permanent notes on files and tasks
- XFT Organizer as a central cockpit for file management
  - Integration of searches
  - Link to all required SAP transactions
  - Overview of the processes last edited
  - Favorites function



### Process Integration and Control

- Mapping of processes and objects relevant for these processes
- Definition of status networks, deadlines, and responsibilities at task level
- Task-related deadline and status monitoring
- Ad-hoc enhancement of the process by the user can be permitted
- Resubmission function for the entire file, sections, and individual tasks
- Status-dependent activation and deactivation of file functions
- Together with the integrated XFT Compliance Cycle, approvals can be obtained or tasks distributed
- Integration of processes from SAP Business Workflows, mail processes, or background processes controlled using XFT Queue Manager (such as task forwarding)
- Process action modeling using a custom action control component

- Drag and drop from the Windows file system
- Drag and drop e-mails and attachments (directly from the mail client using Outlook plug-in)
- Export the file to the Windows file system
- Document preview with navigation feature within the file
- Integrated template management for MS Word templates (with data flow)
- Document Inbound
  - Document inbound processes
  - Scanning integration using SAP ArchiveLink standard procedures (barcode, dialog scanning, and so on)
  - Document check-in
- XFT Super Document
  - High-performance access to documents, taking into account SAP locations and cache servers)
  - Document display according to document type
  - Document editing directly from the file (including non-Office documents)
- XFT Upload Manager
  - The user can continue to work in the file during document storage
  - This reduces the storage time, particularly for very slow system connections or large files
- Integration of the SAP full-text search

- Full integration with SAP Folders Management, SAP Case Management, and SAP Business

- High degree of integration with all SAP business applications and business objects
- File can display objects integrated from different SAP systems and content servers
